In this connection, it is intimated that license for running and operation of Health Club at Hotel Rajhans, Surajkund was granted to M/s Sharma & Co. for the period from 19.08.1999 to 31.03.2004. The party started committing default in the payment of license money from 2nd installment onwards and left the premises without completion of license period. Thus the firm M/s Sharma & Co. violated the terms and conditions of agreement and caused loss to the Corporation.

Accordingly, the firm M/s Sharma & Co. was blacklisted for future business/ transaction with Haryana Tourism Corporation Ltd. vide this office letter No.HTC/PPP/2020/1387 dated 09.11.2020 (copy enclosed).

Hence, you had deviated and violated the terms and conditions of the agreement and had caused financial loss to the Haryana Tourism Corporation. So, it has been decided that henceforth, Haryana Tourism Corporation would not carry out any future business / transaction either with you or with any of your firms.

Accordingly, your firms stand black listed for future business/ transaction with the Haryana Tourism Corporation for violating the terms and conditions and causing financial loss to the Corporation.
